OFFICE MEMORANDUM

The State Government have implemented the revised UGC scale of pay in favour of University, Government College and Non-Government Aided College teachers in Resolution No.34492 dated 14.12.2009. As per the above Resolution, Government have issued Notification vide S.R.O. No.2306 dated 28.01.2010 to extend the UGC scale to Government College teachers under the nomenclature, Orissa Revised Scale of Pay (for college teachers) Rules-2010 which is effective from 1st day of January 2006.

Finance Department have issued their Office Memorandum and Resolution for pre-2006 and post-2006 pensioners and family pensioners vide their Office Memorandum No.3667 dated 19.01.2009 and Resolution No.3653 dated 19.01.2009 respectively for revision of their Pension/Family Pension with effect from 01.01.2006.

These above Office Memorandum and Resolution issued by the Finance Department will also be applicable to the Government college teachers who have come under UGC scale of pay for pre-2006 and post-2006 pensioners and family pensioners respectively in accordance with the provisions contained in this Department Resolution No.34492 dated 14.12.2009.

So far as arrears concerned, 40% of the arrears out of such revision shall be paid to the pensioners/family pensioners during the financial year 2009-10 and the balance 60% of the arrears will be paid as per decision of Government at later stage.




